A bond of indemnity will ordinarily be required, but only on a form that will be provided, when necessary. The Secretary of the Treasury reserves the right to require additional evidence in any particular case.

COMPLETION OF FORM – Print clearly in ink or type all information requested. If more space is needed for any item, use a plain sheet of paper and attach it to this form.

- **ITEM 1.** Describe the securities. Provide as much information as possible. Show the owner's Social Security Number or the Employer Identification Number, if one has been assigned.
- **ITEM 2.** You must be an officer or a general partner to execute the application on behalf of your organization. Provide your complete name and your official title.
